Specifically, the undersigned on his/her/their own behalf or on behalf of his/ her/their child, if such child in under the age of eighteen, as applicable (collectively, unless otherwise specifically provided, "Releasor"), does hereby state that:*

1. Releasor does hereby agree that Releasees may utilize Releasor's name, image and biographical data to publicize Releasees and/or the Stagedoor Manor Studios in any and all media and from and after this day, in perpetuity without any further compensation, consent or approval. Refunds

- No refunds will be given if the student decides to no longer take the class after initial purchase.

- If there is a technical issue that results in a delay of an individual student attending the class, no refunds will be given.
- If there is a sitewide technical issue, classes will be rescheduled and not refunded.

- If for any reason a student needs to reschedule a session, a minimum of 24 hours is required to reschedule the class. Each student is allowed a total of one class to be rescheduled.
